

- I think when experienced palliative professionals are trying to teach others and help others to develop their programs, they need to be careful about saying that "palliative care is not hospice care and not 'just' for end of life. We need to be careful not to continue to perpetuate these prejudices. End of life care is complex and a vital part of medicine. Palliative care is a vital part of patient care and will eventually lead to end of life. Just saying that I hear nurses and physicians using these terms so that patients won't refuse palliative care. We need to continue to work against the negative image of hospice while being truthful to patients and their families. I am very proud to say that I was a hospice nurse for 10 years and helped to relieve suffering, and we should refrain from using language that may unintentionally shed a negative light on end of life care. Nevertheless, I appreciate your efforts for educating the medical community about palliative care.
